## **Client Story**

Once upon a time in New York City, successful investor Mr. Thompson met with his advisor, Mr.

Mr. Matthews explained that Mr.

500's focus on US Large Cap
Growth stocks. Furthermore, Mr.

25,000 unique holdings, far
surpassing the 500 companies in

They discussed the challenging "Dead Decade" from 2000 to 2010



when the S&P 500 remained flat, while Mr. Thompson's diversified portfolio generated consistent returns. They also addressed the dominance of tech stocks in the market, which posed risks due to their concentration and vulnerability to factors like rising interest rates.

Mr. Matthews stressed the importance of diversification and prudent investing. He explained that while the S&P 500's tech stocks were currently driving market gains, relying too heavily on a few stocks or a single sector increased the risk of market instability.

Leaving the meeting, Mr.
Thompson felt reassured. He understood the value of owning equities, diversifying his investments, and regularly rebalancing his portfolio. His well-diversified academic based portfolio was designed to withstand market fluctuations and protect his wealth.
